ENROLLED SENATE BILL No. 215

AN ACT to make and adjust appropriations for the legislature, judiciary, and department of social services for the fiscal year ending September 30, 1991; and to provide for the expenditure of the appropriations.

The People of the State of Michigan enact:

Sec. 101. There is appropriated for the legislature, judiciary, and department of social services to supplement former appropriations for the fiscal year ending September 30, 1991, the following amounts:

GENERAL SECTIONS

Sec. 201. In accordance with the provisions of section 30 of article IX of the state constitution of 1963, total state spending from state sources in section 101 is \$100,928,600.00. There are no state appropriations to be paid to local units of government in section 101.

Sec. 202. The appropriations made and the expenditures authorized under this act and the departments, agencies, commissions, boards, offices, and programs for which an appropriation is made under this act are subject to the management and budget act, Act No. 431 of the Public Acts of 1984, being sections 18.1101 to 18.1594 of the Michigan Compiled Laws.

DEPARTMENT OF SOCIAL SERVICES

Sec. 301. (1) The funds appropriated for hospital disproportionate share payments in section 101 are for a special one-time payment and shall not affect the payments made to hospitals under the regular disproportionate share adjustor to medicaid prices per case (DRG or per diem).

(2) Contributions to the general fund will be used to support the medicaid program. Payments to an eligible hospital under this provision will be made in accordance with medicaid policy and will not be dependent upon, or in return for, a contribution from the eligible hospital.

Sec. 302. The department is authorized to restore payment rates for outpatient hospital fees and associated outpatient hospital adjustors to the levels in effect January 1, 1991.

This act is ordered to take immediate effect.
