- 5 SEC. 1282A. (1) AS USED IN THIS SECTION:
- 6 (A) "ESSENTIAL AND EMPLOYABILITY SKILLS ASSESSMENT PROGRAM"
- 7 MEANS 1 OR MORE INSTRUMENTS ADMINISTERED BY A LOCAL SCHOOL
- 8 DISTRICT FOR THE PURPOSE OF DETERMINING A PUPIL'S PROFICIENCY IN
- 9 ENGLISH, MATHEMATICS, SCIENCE, AND OTHER SUBJECT AREAS AS

- 1 DESIGNATED BY THE STATE BOARD. THE ASSESSMENT PROGRAM SHALL ALSO
- 2 BE USED TO DETERMINE PROFICIENCY IN SELECTED EMPLOYABILITY SKILLS

- 4 (B) "INSTRUMENT" MEANS A WRITTEN, ORAL, OR OTHER METHOD OF

- 3 DISTRICTS ESSENTIAL AND EMPLOYABILITY SKILLS ASSESSMENT
- 4 INSTRUMENTS.
- 5 (5) BEGINNING SEPTEMBER 1, 1993, THE BOARD OF EACH SCHOOL
- 6 DISTRICT SHALL PROVIDE THAT FOR EACH PUPIL ENROLLED IN THE EIGHTH
- 7 GRADE OF A PUBLIC SCHOOL AN ESSENTIAL AND EMPLOYABILITY SKILLS
- 8 INVENTORY IS DEVELOPED THAT INCLUDES, BUT IS NOT LIMITED TO, THE
- 9 PUPIL'S RESULTS FROM ESSENTIAL AND EMPLOYABILITY SKILLS ASSESS-
- 10 MENT INSTRUMENTS AND OTHER EVIDENCE OF ACADEMIC, TEAMWORK, AND
- 11 PERSONAL MANAGEMENT ATTAINMENTS. THE ESSENTIAL AND EMPLOYABILITY
- 12 SKILLS INVENTORY FOR EACH PUPIL SHALL BE EVALUATED AND AN EDUCA-
- 13 TIONAL PROGRAM DEVELOPED FOR THE PUPIL BEFORE THE END OF THE

- 19 ASSESSMENT INSTRUMENT SHALL BE PROVIDED THE OPPORTUNITY TO ATTAIN
- 20 PROFICIENCY IN THAT SUBJECT OR SKILL AREA AND SHALL BE REEVALU-
- 21 ATED EACH SCHOOL YEAR UNTIL THE PUPIL IS ASSESSED AS PROFICIENT

- 23 (7) TO PROVIDE A PUPIL WITH THE OPPORTUNITY TO ATTAIN PROFI-

- 6 SCHOOL DISTRICT AND APPROVED BY THE DEPARTMENT.
- 7 (D) AN ACADEMIC OR VOCATIONAL PROGRAM CONDUCTED BY A COMMU-
- 8 NITY COLLEGE.
- 9 (E) A DROPOUT PREVENTION PROGRAM.
- 10 (8) AN INTERMEDIATE SCHOOL DISTRICT, EITHER SOLELY OR AS
- 11 PART OF A CONSORTIUM OF INTERMEDIATE SCHOOL DISTRICTS, MAY PRO-
- 12 VIDE THE EDUCATIONAL PROGRAMS DESCRIBED IN SUBSECTION (7) ON
- 13 BEHALF OF 1 OR MORE SCHOOL DISTRICTS.
- 14 (9) THE BOARD OF EACH SCHOOL DISTRICT SHALL MAKE AVAILABLE
- 15 TO THE STATE BOARD AND THE PUBLIC IN AN ANNUAL REPORT THE RESULTS
- 16 OF THE ESSENTIAL AND EMPLOYABILITY SKILLS ASSESSMENT PROGRAM ON A
- 17 DISTRICT AND BUILDING-BY-BUILDING BASIS.
- 18 (10) NOT LATER THAN JANUARY 1, 1997 AND EACH YEAR THEREAF-
- 19 TER, THE STATE BOARD SHALL SUBMIT IN WRITING A SUMMARY ANALYSIS
- 20 OF THE ESSENTIAL AND EMPLOYABILITY SKILLS ASSESSMENT PROGRAM TO
- 21 THE SENATE AND HOUSE COMMITTEES THAT HAVE THE RESPONSIBILITY FOR
- 22 EDUCATION LEGISLATION.
- 23 (11) THE STATE BOARD MAY EXEMPT SPECIAL EDUCATION PUPILS
- 24 FROM THE REQUIREMENTS OF THIS SECTION, BUT SHALL PROVIDE FOR SPE-
- 25 CIAL EDUCATION PUPILS TO HAVE AVAILABLE AN ASSESSMENT AND CERTI-
- 26 FICATION OF THEIR PROFICIENCY IN VARIOUS SUBJECTS AND SKILLS
- 27 BEFORE COMPLETION OF THEIR SCHOOL DISTRICT OR OTHER PUBLIC

- 1 SUPPORTED EDUCATION. THE SCHOOL DISTRICT IN WHICH A SPECIAL

 2 EDUCATION PUPIL IS ENROLLED SHALL IMPLEMENT THIS SUBSECTION AND

 3 SHALL PROVIDE THAT ANY ASSESSMENT OF THE PUPIL BE IN A FORM

 4 APPROPRIATE TO THE SPECIAL NEEDS OF THE PUPIL.
