- 8 SEC. 9403. A HEALTH PROFESSIONAL WHO CONDUCTS A COMPREHEN-
- 9 SIVE HEALTH SCREENING PURSUANT TO SECTION 9402 SHALL DO ALL OF
- 10 THE FOLLOWING:
- 11 (A) MEET WITH THE MINOR AND HIS OR HER PARENT, GUARDIAN, OR
- 12 PERSON IN LOCO PARENTIS TO EXPLAIN THE RESULTS OF THE COMPREHEN-
- 13 SIVE HEALTH SCREENING.
- 14 (B) REFER THE MINOR, AS NECESSARY, TO OTHER HEALTH PROFES-

- 19 SEC. 9406. (1) A PUBLIC SCHOOL SHALL MAINTAIN THE COMPRE-
- 20 HENSIVE HEALTH SCREENING SUMMARY FORM OF EACH MINOR ATTENDING
- 21 THAT PUBLIC SCHOOL. WHEN A MINOR TRANSFERS TO ANOTHER PUBLIC
- 22 SCHOOL WITHIN THE STATE, THE PUBLIC SCHOOL THAT MAINTAINS THAT
- 23 MINOR'S COMPREHENSIVE HEALTH SCREENING SUMMARY FORM SHALL TRANS-
