## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Act No. 280 of the Public Acts of 1939, as
- 2 amended, being sections 400.1 to 400.121 of the Michigan Compiled
- 3 Laws, is amended by adding section 111k to read as follows:
- 4 SEC. 111K. (1) THE STATE DEPARTMENT SHALL PAY PROVIDERS OF
- 5 MEDICAL SERVICES RENDERED TO MEDICALLY INDIGENT INDIVIDUALS UNDER
- 6 THIS ACT WITHIN 30 DAYS OF THE TIME THE STATE DEPARTMENT RECEIVES
- 7 A PROPER STATEMENT. FOR PURPOSES OF THIS SECTION, A PROPER
- 8 STATEMENT IS A STATEMENT MEETING THE REQUIREMENTS OF THIS ACT OR
- 9 RULES PROMULGATED PURSUANT TO THIS ACT.

- 1 (2) THE STATE DEPARTMENT SHALL PAY INTEREST TO PROVIDERS ON
- 2 AMOUNTS NOT PAID IN COMPLIANCE WITH SUBSECTION (1), AT THE RATE
- 3 DETERMINED UNDER SECTION 23(2) OF ACT NO. 122 OF THE PUBLIC ACTS
- 4 OF 1941, BEING SECTION 205.23 OF THE MICHIGAN COMPILED LAWS. THE
- 5 STATE DEPARTMENT SHALL PAY INTEREST FROM THE THIRTY-FIRST DAY
- 6 FOLLOWING THE DATE IT RECEIVES A PROPER STATEMENT TO THE DATE IT
- 7 MAILS PAYMENT TO THE PROVIDER.
- (3) THE STATE DEPARTMENT SHALL COMPLY WITH ACCOUNTING MANUAL
- 9 PROCEDURES OF THE DEPARTMENT OF MANAGEMENT AND BUDGET, INCLUDING
- 10 ALL OF THE FOLLOWING:
- 11 (A) RECORDING PROVIDER PAYMENT DUE DATES ON PAYMENT
- 12 VOUCHERS.
- 13 (B) DATE-STAMPING PROVIDER INVOICES WHEN RECEIVED.
- 14 (C) ENTERING PAYMENT DUE DATES ON THE STATE DEPARTMENT'S
- 15 COMPUTER SYSTEM.
