"An act to regulate and license the selling, purchasing, possessing, and carrying of certain firearms and gas ejecting devices; to prohibit the buying, selling, or carrying of certain firearms and gas ejecting devices without a license; and to repeal all acts and parts of acts inconsistent with the provisions of this act,"

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 6a of Act No. 372 of the Public Acts of
- 2 1927, as amended by Act No. 345 of the Public Acts of 1980, being
- 3 section 28.426a of the Michigan Compiled Laws, is amended to read
- 4 as follows:
- 5 Sec. 6a. (1) A concealed weapons licensing board may issue
- 6 to any bank, trust company, armored car company, railway company,

- 2 individual having in its, their, or the individual's possession
