HOUSE BILL No. 4136

February 7, 1991, Introduced by Reps. O'Neill and Jondahl and referred to the Committee on Taxation.

A bill to amend sections 3 and 4 of Act No. 112 of the Public Acts of 1961, entitled

"An act to authorize and provide for the issuance and sale of bonds and notes of the state; to provide funds for making loans to school districts for payment of principal and interest on certain school bonds; and to provide for use of moneys repaid to the state by school districts,"

being sections 388.983 and 388.984 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Sections 3 and 4 of Act No. 112 of the Public

- 13 Sec. 4. (1) Any -moneys- MONEY repaid by school districts
- 14 BEFORE OCTOBER 1, 1991 on loans made from the school bond loan
- 15 fund shall -first be used to pay principal and interest on out-
- 16 standing bonds or notes issued under the provisions of this act
- 17 becoming due during the next ensuing 12 month period and any
- 18 expenses incurred in connection therewith. Any moneys thereafter
- 19 remaining may be deposited in the school bond loan fund and used
