- 7 (B) "PANEL" MEANS THE CHILD MORTALITY REVIEW PANEL CREATED

- 1 SEC. 2503. (1) THE CHILD MORTALITY REVIEW PANEL IS CREATED
- 2 IN THE DEPARTMENT TO CONDUCT MULTIDISCIPLINARY REVIEW OF CHILD
- 3 DEATHS. THE PANEL SHALL BE APPOINTED BY THE DEPARTMENT AND SHALL
- 4 CONSIST OF ALL OF THE FOLLOWING INDIVIDUALS:

- 15 (H) A REPRESENTATIVE FROM A SCHOOL OF PUBLIC HEALTH OF A
- 16 MICHIGAN PUBLIC UNIVERSITY.
- 17 (I) A REPRESENTATIVE FROM A LOCAL COMMUNITY PROGRAM THAT
- 18 DEALS WITH ISSUES RELATED TO CHILD MORTALITY.
- 19 (2) IN ADDITION TO THE MEMBERS APPOINTED UNDER SUBSECTION
- 20 (1), A REPRESENTATIVE OF THE DEPARTMENT AND A REPRESENTATIVE FROM

- 25 SHALL BE REIMBURSED FOR THEIR EXPENSES ACCORDING TO

- 1 (4) THE PANEL MAY ESTABLISH SUBCOMMITTEES AS IT CONSIDERS
- 2 NECESSARY TO ADDRESS SPECIFIC ISSUES RELATED TO CHILD MORTALITY.
- 3 SEC. 2505. (1) THE PANEL SHALL DO ALL OF THE FOLLOWING:
- 4 (A) DEVELOP POLICIES AND PROCEDURES FOR SYSTEMATIC REVIEW
- 5 AND ANALYSIS OF CHILD DEATHS AND MORTALITY TRENDS AND PATTERNS IN
- 6 THIS STATE IN ORDER TO RECOMMEND REMEDIAL ACTION.
- 7 (B) REVIEW CHILD FATALITIES IN MICHIGAN.
- 8 (C) REVIEW POLICIES AND PRACTICES TO DETERMINE THE ADEQUACY
- 9 OF PROTECTION AFFORDED TO CHILDREN AND THE EXTENT TO WHICH THE
- 10 NUMBER OF PREVENTABLE CHILD DEATHS CAN BE REDUCED.
- (D) CONDUCT A BROAD CHILD MORTALITY SURVEILLANCE FUNCTION
- 12 WITH A STATEWIDE FOCUS.
- 13 (E) BEGINNING NOT LATER THAN 1 YEAR AFTER THE PANEL IS
- 14 APPOINTED, ANNUALLY MAKE RECOMMENDATIONS TO THE DEPARTMENT, GOV-
- 15 ERNOR, AND THE LEGISLATURE ON MEASURES TO BE TAKEN FOR INTERVEN-
- 16 TION TO AVOID CHILD DEATHS. THE RECOMMENDATIONS SHALL BE BASED
- 17 ON THE PANEL'S FINDINGS AND SHALL ADDRESS GAPS OR PROBLEMS IN
- 18 STATUTE, POLICY, ADMINISTRATION, INTERAGENCY OR INTERDISCIPLINARY
- 19 COOPERATION, TRAINING, AND RESOURCES.
- 20 (2) IN CARRYING OUT ITS DUTIES UNDER SUBSECTION (1), THE
- 21 PANEL MAY GIVE PRIORITY TO A SPECIFIC CAUSE OR CAUSES OF CHILD
- 22 DEATHS OVER OTHERS.
- 23 (3) THE DEPARTMENT MAY PROMULGATE RULES IT CONSIDERS NECES-
- 24 SARY TO IMPLEMENT THIS PART.
- 25 SEC. 2507. THE DEPARTMENT SHALL PROVIDE ALL OF THE FOLLOW-
- 26 ING TO THE PANEL:

- 1 (A) STAFF SUPPORT AND ASSISTANCE.
- 2 (B) USE OF THE DEPARTMENT'S NETWORK OF MEDICAL ADVISORY
- 3 BODIES FOR PROVISION OF MEDICAL EXPERTISE.
- 4 (C) USE OF THE DEPARTMENT'S RECORDS AND REPORTING CAPACITY
- 5 FOR MORTALITY SURVEILLANCE TO SUPPORT THE REVIEW PROCESS.
- (D) PEDIATRIC MEDICINE CONSULTATION.
- 7 SEC. 2509. THIS PART IS REPEALED UPON THE EXPIRATION OF 3
- 8 YEARS AFTER ITS EFFECTIVE DATE.
