A bill to amend section 8 of Act No. 128 of the Public Acts of 1985, entitled as amended

"Great Lakes protection act,"

as added by Act No. 156 of the Public Acts of 1989, being section 323.38 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 8 of Act No. 128 of the Public Acts of
- 2 1985, as added by Act No. 156 of the Public Acts of 1989, being
- 3 section 323.38 of the Michigan Compiled Laws, is amended to read
- 4 as follows:
- 5 Sec. 8. (1) The Michigan Great Lakes protection fund tech-
- 6 nical advisory board is created within the water resources
- 7 commission. The board shall consist of the following members:

- 1 (a) A citizen member of the water resources commission or an
- 2 individual appointed by the water resources commission who has
- 3 knowledge or expertise in Great Lakes water issues.
- 4 (b) A citizen member of the air pollution control commission
- 5 or an individual appointed by the air pollution control commis-
- 6 sion who has knowledge or expertise in the effects of air pollu-
- 7 tion on the Great Lakes.
- 8 (c) Six individuals appointed by the commission of -natural
- 9 resources CONSERVATION AND RECREATION as follows:
- (i) One individual from an environmental organization.
- (ii) One individual from a business or industry related to
- 12 the Great Lakes.
- (iii) One individual who has performed research related to
- 14 the water quality of the Great Lakes.
- (iv) One individual who has performed research related to
- 16 public health concerns associated with the Great Lakes.
- (v) One individual who has knowledge or expertise in the
- 18 demographics of the Great Lakes region or the climatology of the
- 19 Great Lakes region.
- 20 (vi) One individual who represents the hazardous substance
- 21 research center.
- 22 (2) A member of the board shall serve for a term of 3
- 23 years. However, of the first appointments to the board by the
- 24 commission of -natural resources CONSERVATION AND RECREATION
- 25 under subsection (1)(c), 3 shall be appointed to serve 2-year
- 26 terms and 3 shall be appointed to serve 1-year terms.

- 1 (3) A member of the board may be removed for inefficiency, 2 neglect of duty, or malfeasance in office by the body that
- 3 appointed him or her.
- 4 (4) The board shall elect a chairperson from among its
- 5 members. The board shall meet at the call of the chairperson at
- 6 least annually. A meeting of the board shall be held in compli-
- 7 ance with the open meetings act, Act No. 267 of the Public Acts
- 8 of 1976, being sections 15.261 to 15.275 of the Michigan Compiled
- 9 Laws. Public notice of the time, date, and place of the meeting
- 10 shall be given in the manner required by that act.
- (5) A member of the board shall not receive a grant under
- 12 this act.
- 13 Section 2. This amendatory act shall not take effect unless
- 14 all of the following bills of the 86th Legislature are enacted
- 15 into law:
