A bill to amend sections 251, 254, and 255 of Act No. 380 of the Public Acts of 1965, entitled

"Executive organization act of 1965,"

being sections 16.351, 16.354, and 16.355 of the Michigan Compiled Laws; and to add section 254a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Sections 251, 254, and 255 of Act No. 380 of the
- 2 Public Acts of 1965, being sections 16.351, 16.354, and 16.355 of
- 3 the Michigan Compiled Laws, are amended and section 254a is added
- 4 to read as follows:
- 5 Sec. 251. The head of the department of natural resources
- 6 is JOINTLY HELD BY the commission of natural resources AND THE
- 7 COMMISSION OF CONSERVATION AND RECREATION.
- 8 Sec. 254. The commission of natural resources shall
