February 7, 1991, Introduced by Rep. Alley and referred to the Committee on Conservation, Recreation and Environment.

A bill to amend section 1 of Act No. 107 of the Public Acts of 1951, entitled

"An act to authorize the sale and conveyance of certain tax lands, the title to which has revested in the state by reason of abandonment of the public use of said lands,"

being section 211.641 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 1 of Act No. 107 of the Public Acts of
- 2 1951, being section 211.641 of the Michigan Compiled Laws, is
- 3 amended to read as follows:
- 4 Sec. 1. Whenever the title to any land, heretofore
- 5 PREVIOUSLY conveyed, under FORMER section 7 or FORMER section 8
- 6 of Act No. 155 of the Public Acts of 1937, as amended, being
- 7 sections 211.357 and 211.358 of the MICHIGAN Compiled Laws, -of
- 8 1948, to a municipality for public use, revests in the state of
- 9 Michigan for the reason that the proposed public use has been

- 1 abandoned or terminated and -such THE land constitutes highway
