- 5 Sec. 2. As used in this act:
- 6 (a) "Commission" means the commission of natural resources
- 7 CONSERVATION AND RECREATION.
- 8 (b) "Department" means the department of natural resources.

 2 director's authorized representative.
- 3 (d) "Endangered species" means any species of fish, plant
- 4 life, or wildlife which is in danger of extinction throughout all
- 5 or a significant part of its range other than a species of inse-
- 6 cta determined by the commission or the secretary of the United
- 7 States department of the interior to constitute a pest whose pro-
- 8 tection under this act would present an overwhelming and overrid-
- 9 ing risk to man.
- (e) "Fish or wildlife" means any member of the animal king-
- 11 dom, including any mammal, fish, amphibian, mollusk, crustacean,
- 12 arthropod, or other invertebrate, and includes any part, product,
- 13 egg, or offspring, or the dead body or parts thereof. Fish or
- 14 wildlife includes migratory birds, nonmigratory birds, or endan-
- 15 gered birds for which protection is afforded by treaty or other
- 16 international agreement.
- (f) "Import" means to bring into, or introduce into, or
- 18 attempt to bring into, or introduce into, any place subject to
- 19 the jurisdiction of this state.
- 20 (q) "Person" means an individual, corporation, partnership,
- 21 trust, association, or any other private entity, or any officer,
- 22 agent, department, or instrumentality of the federal government,
- 23 of a state or political subdivision of a state, or of any foreign
- 24 government.
- 25 (h) "Plant or plant life" means any member of the plant
- 26 kingdom, including seeds, roots, and other parts of a member of
- 27 the plant kingdom.

- 1 (i) "Species" includes any subspecies of fish, plant life,
- 2 or wildlife and any other group of fish, plants, or wildlife of
- 3 the same species or smaller taxa in common spatial arrangement
- 4 that interbreed or cross-pollinate when mature.
- 5 (j) "Take" means, in reference to fish and wildlife, to
- 6 harass, harm, pursue, hunt, shoot, wound, kill, trap, capture,
- 7 collect, or attempt to engage in any such conduct.
- 8 (k) "Take" means, in reference to plants, to collect, pick,
- 9 cut, dig up, or destroy in any manner.
- 10 (ℓ) "Threatened species" means any species which is likely
- 11 to become an endangered species within the foreseeable future
- 12 throughout all or a significant portion of its range.
