A bill to amend sections 1, 3, and 4 of Act No. 230 of the Public Acts of 1925, entitled as amended

"An act to provide for the better protection and preservation of fish, game and fur-bearing animals and game birds, protected by the laws of this state; to provide a method by which the taking or killing thereof may be regulated and the open season for the taking or killing thereof suspended or abridged in any designated waters or area of this state; to provide for special fisheries research and regulations therefor; to provide a penalty for the violation thereof, and to repeal Act No. 9 of the Public Acts of 1917, as amended by Act No. 156 of the Public Acts of 1921,"

section 3 as amended by Act No. 53 of the Public Acts of 1990, being sections 300.1, 300.3, and 300.4 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 1. 1 protection in any designated waters or area within the state, the 2 commission may make and promulgate an order suspending or abridg-3 ing the open season on fish, game or fur-bearing animals, or game 4 birds, or may regulate their taking or killing in the waters or 5 area as in the judgment of the commission may be necessary or 6 expedient for the further protection of fish, game or fur-bearing 7 animals, or game birds in those waters or areas, and shall in the 8 order clearly specify the manner and condition relative to the 9 taking or killing. The orders shall clearly and distinctly 10 describe and set forth the waters or area affected by each order, 11 and whether the order is applicable to all fish, game or 12 fur-bearing animals, or game birds, or only to certain kinds or 13 species designated in the order and shall also clearly specify 14 and set forth the length of time during which the order shall 15 remain in force and effect, that shall not exceed 5 years. 16 public shall be notified of orders changing the rules pertaining 17 to hunting, fishing, or trapping in the annual hunting, fishing, 18 and trapping guides available by licensed agents of the depart-19 ment of natural resources and field offices of the department or 20 the department of natural resources may publish the orders at 21 least 21 days but not more than 60 days prior to taking effect, 22 and at least once annually while in force, in at least 1 newspa-23 per in each county, if a newspaper is published in a county, the 24 whole or any portion of which is affected by the order. 25 first newspaper publication shall appear at least once each week 26 for 3 successive weeks. - 9 seasons established by law for the taking of fish for commercial
- 10 purposes from the waters of lakes Superior, Michigan, Huron, Erie
