

HOUSE BILL No. 4208

February 7, 1991, Introduced by Rep. Alley and referred to the Committee on Conservation, Recreation and Environment.

A bill to amend the title and section 1 of Act No. 192 of the Public Acts of 1929, entitled as amended

"An act to prescribe certain powers and duties of the director of conservation; to provide for the enforcement of the laws relative to the protection, propagation or preservation of wild birds, wild animals and fish; to provide for the enforcement of laws pertaining to the powers and duties of the director of conservation or the commission of conservation; to provide for the condemnation of property seized for violation of such statutes and laws; to declare as peace officers the director of the department of natural resources and any conservation officer appointed by him or her and to vest in the director and conservation officers all the powers, privileges, prerogatives, and immunities of peace officers under the general laws of the state; to provide for volunteer conservation officers and vest in them all the immunities of conservation officers under the general laws of the state; and to prescribe certain penalties,"

being section 300.11 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. The title and section 1 of Act No. 192 of the
2 Public Acts of 1929, being section 300.11 of the Michigan
3 Compiled Laws, are amended to read as follows:

16 provide for volunteer conservation officers and vest in them all
17 the immunities of conservation officers under the general laws of
18 the state; and to prescribe certain penalties.

5 punishing any person for the violation of ~~said~~ THESE statutes
6 or laws. Such actions and proceedings shall be brought in the
7 name of the people in like cases in the same courts and under the
8 same procedure as they may ~~now or may hereafter~~ be brought by
9 any individual or by the prosecuting attorneys of the several
10 counties under and by virtue of any statute or law. ~~now existing~~
