THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Act No. 251 of the Public Acts of 1968, as

- 5 SEC. 8A. (1) EXCEPT AS OTHERWISE PROVIDED IN SUBSECTION (2)
- 6 OR (3), A GRAVE MEMORIAL THAT HAS BEEN INSTALLED SHALL NOT BE
- 7 MOVED, DISTURBED, DISRUPTED, OR BE SUBJECTED TO FLUSHING WITHOUT
- 8 THE PERMISSION OF THE DECEASED'S SURVIVING SPOUSE, CHILD, OR

- 1 PARENT, OR IF THERE IS NO SURVIVING SPOUSE, CHILD, OR PARENT, A
- 2 SURVIVING NEXT OF KIN, IF ANY.
- 3 (2) AN EMPLOYEE OR AGENT OF A CEMETERY MAY PERFORM THE FOL-
- 4 LOWING ACTIONS ON A GRAVE MEMORIAL THAT HAS BEEN INSTALLED:
- 5 (A) TEMPORARILY MOVE, REMOVE, DISTURB, OR DISRUPT THE GRAVE
- 6 MEMORIAL IF THE ACTION IS NECESSARY FOR ITS REPAIR OR RESETTING:
- 7 THE INSTALLATION OF AN ADJACENT GRAVE MEMORIAL; OR FOR AN INTER-
- 8 MENT, DISINTERMENT, OR MAINTENANCE OF THE CEMETERY AS LONG AS THE
- 9 GRAVE MEMORIAL IS REINSTALLED.
- 10 (B) REMOVE A GRAVE MEMORIAL THAT IS BROKEN OR OTHERWISE IN A
- 11 CONDITION THAT WOULD BE HAZARDOUS TO THE GENERAL PUBLIC.
- 12 (C) REMOVE A GRAVE MEMORIAL THAT WAS PURCHASED FROM THE CEM-
- 13 ETERY ON AN INSTALLMENT BASIS WHERE THE CONSUMER PURCHASING THE
- 14 GRAVE MEMORIAL HAS DEFAULTED. IN SUCH A CASE, THE CEMETERY SHALL
- 15 PROVIDE 10 DAYS' WRITTEN NOTICE TO THE PURCHASER OF THE DEFAULT
- 16 AND OF ITS INTENT TO REMOVE THE MEMORIAL. THE CEMETERY SHALL
