## **HOUSE BILL No. 4313**

A bill to amend section 1702 of Act No. 268 of the Public Acts of 1986, entitled as amended

"Legislative council act,"

as added by Act No. 123 of the Public Acts of 1987, being section 4.1702 of the Michigan Compiled Laws.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 1702 of Act No. 268 of the Public Acts
- 2 of 1986, as added by Act No. 123 of the Public Acts of 1987,
- 3 being section 4.1702 of the Michigan Compiled Laws, is amended to
- 4 read as follows:
- 5 Sec. 1702. (1) The Michigan capitol committee shall advise
- 6 and make recommendations to the governor, the senate majority
- 7 leader, and the speaker of the house of representatives regarding
- 8 the restoration and preservation of the state capitol building
- 9 and the management, operation, development, construction,

- 1 renovation, maintenance, and repair of the state capitol building
- 2 and grounds. -Such THE recommendations shall take effect 15
- 3 days after the submission to the governor, senate majority
- 4 leader, and speaker of the house of representatives unless
- 5 rejected in writing by the governor, senate majority leader, or
- 6 speaker of the house of representatives.
- 7 (2) In carrying out the powers and duties prescribed under
- 8 subsection (1), the Michigan capitol committee shall do all of
- 9 the following:
- 10 (a) Develop and recommend written procedures for the opera-
- 11 tion of the Michigan capitol committee.
- (b) Make recommendations to the governor, the majority
- 13 leader of the senate, and the speaker of the house of representa-
- 14 tives regarding the implementation of all permanent physical
- 15 changes to be made in or on the capitol building and all physical
- 16 changes to be made on the grounds of the capitol building.
- 17 (c) Make recommendations to the governor, the majority
- 18 leader of the senate, and the speaker of the house of representa-
- 19 tives regarding the implementation of a state capitol building
- 20 master plan.
- 21 (d) Make recommendations to the governor, the majority
- 22 leader of the senate, and the speaker of the house of representa-
- 23 tives regarding public and private financial support for the
- 24 development, construction, renovation, and preservation of the
- 25 capitol building and grounds.
- (e) Make recommendations to the governor, the majority
- 27 leader of the senate, and the speaker of the house of

- 1 representatives regarding the selection, design, and placement of 2 statues, memorials, trees, and plants on the grounds of the capi-
- 3 tol building.
- 4 (3) The Michigan capitol committee shall have powers which
- 5 THAT are necessary or appropriate to perform the duties and exer-
- 6 cise the powers prescribed under this chapter and -which THAT
- 7 are not otherwise prohibited by law, including:
- 8 (a) Contracting with the department of management and budget
- 9 or any other public or private entity.
- (b) Appointing advisory committees.
- (4) The current labor and trades and safety and regulatory
- 12 classifications performing duties on the capitol premises shall
- 13 be maintained.
- 14 (5) The Michigan capitol committee -shall DOES not have
- 15 authority -nor OR exercise control over the internal decisions
- 16 of the senate or the house of representatives as they relate to
- 17 the allocation of space in the capitol building and on the
- 18 grounds, including legislative or staff offices. All decisions
- 19 concerning -such THAT space shall be made according to the rules
- 20 or practices of the respective bodies.
- 21 (6) THE MICHIGAN CAPITOL COMMITTEE DOES NOT HAVE AUTHORITY
- 22 OR EXERCISE CONTROL OVER THE SELECTION, DESIGN, OR CONSTRUCTION,
- 23 OR THE FINANCING FOR THE SELECTION, DESIGN, OR CONSTRUCTION, OF
- 24 THE MICHIGAN POLICE OFFICERS MEMORIAL MONUMENT TO BE LOCATED ON
- 25 THE GROUNDS PURSUANT TO THE MICHIGAN POLICE OFFICERS MEMORIAL
- 26 ACT, BUT HAS AUTHORITY OVER THE MICHIGAN POLICE OFFICERS MEMORIAL
- 27 MONUMENT AFTER ITS CONSTRUCTION, INCLUDING, BUT NOT LIMITED TO,

- 1 THE ADDITION OF THE NAMES OF MICHIGAN POLICE OFFICERS KILLED IN
- 2 THE LINE OF DUTY AS IDENTIFIED BY THE OFFICE OF CRIMINAL JUSTICE
- 3 IN THE DEPARTMENT OF MANAGEMENT AND BUDGET.
- 4 (7)  $\overline{(6)}$  As used in this section, "grounds" means the prop-
- 5 erty upon which the state capitol building is situated, bordered
- 6 on the north by Ottawa street; on the east by Capitol avenue; on
- 7 the south by Allegan street; and on the west by Walnut street.
- 8 Section 2. This amendatory act shall not take effect unless
- 9 Senate Bill No. \_\_\_\_ or House Bill No. 4312 (request
- 10 no. 01410'91) of the 86th Legislature is enacted into law.
