February 19, 1991, Introduced by Reps. Griffin, Niederstadt and O'Neill and referred to the Committee on Judiciary.

A bill to amend section 31 of Act No. 198 of the Public Acts of 1951, entitled as amended

"Judges' retirement act,"

as amended by Act No. 208 of the Public Acts of 1984, being section 38.831 of the Michigan Compiled Laws; and to add sections 32 and 33.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 31 of Act No. 198 of the Public Acts of
- 2 1951, as amended by Act No. 208 of the Public Acts of 1984, being

- 5 Sec. 31. (1) Beginning January 1, -1983 1992, the retire-
- 6 ment system shall pay the INSURANCE premium for hospital and
- 7 medical surgical and sick care benefits HOSPITALIZATION AND
- 8 MEDICAL COVERAGE, DENTAL COVERAGE, VISION COVERAGE, HEARING

- 1 COVERAGE, OR A COMBINATION OF THESE BENEFITS for a retirant who
- 2 served after January 1, 1983 as a justice of the supreme court,
- 3 judge of the court of appeals, constitutional court administra-

- 5 general, or legislative auditor general, or for his or her
- 6 -retirement allowance beneficiary AND HIS OR HER SPOUSE AND

- 11 HEALTH INSURANCE PLAN OR PLANS UNDER SUBSECTION (1) OR (3) BEFORE
- 12 JULY 1, 1992. HOWEVER, IF A MEMBER WHO RETIRED BEFORE JANUARY 1,
- 13 1992 OR A BENEFICIARY OF THAT RETIRANT ELECTS COVERAGE UNDER THE

- 25 A DECEASED RETIRANT WHO WAS A MEMBER OF THIS RETIREMENT SYSTEM
- 26 BEFORE SEPTEMBER 8, 1961, SHALL BE INCREASED EACH OCTOBER 1
- 27 BEGINNING WITH THE LATER OF OCTOBER 1, 1992 OR THE FIRST OCTOBER
