A bill to amend the title and section 1 of Act No. 246 of the Public Acts of 1945, entitled as amended

"An act to authorize township boards to adopt ordinances and regulations to secure the public health, safety and general welfare; to provide for the establishment of a township police department; to provide for policing of townships by the county sheriff; to provide for the publication of ordinances; to prescribe powers and duties of township boards; to provide penalties; and to repeal all acts and parts of acts in conflict therewith,"

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

(1) The township board of a township may, at a reg-12 ular or special meeting, by a majority of the members elect of 13 the township board, adopt ordinances regulating the public 14 health, safety, and general welfare of persons and property, 15 including, but not limited to, fire protection, licensing or use 16 of bicycles, traffic and parking of vehicles, sidewalk mainte-17 nance and repairs, the licensing of business establishments, and 18 the licensing and regulating of public amusements, and provide

- 19 penalties for the violation of the ordinances. The township
- 20 shall enforce the ordinances and may employ and establish a
- 21 police department with full power to enforce township ordinances
- 22 and state laws. If state laws are to be enforced, a township
- 23 shall have a law enforcement unit or may by resolution appropri-
- 24 ate funds and call upon the sheriff of the county or department
- 25 of state police or other local law enforcement agency in which
- 26 the township is located, THE DEPARTMENT OF STATE POLICE, OR OTHER
- 27 LAW ENFORCEMENT AGENCY to provide special police protection for

- 1 the township. The sheriff, department of state police, or other
- 2 -local law enforcement agency shall, if called upon, provide
- 3 special police protection for the township and enforce local
- 4 township ordinances, to the extent that township funds are appro-
- 5 priated for the enforcement. Special township deputies appointed
- 6 by the sheriff shall be under the jurisdiction of and solely
- 7 responsible to the sheriff. Ordinances regulating traffic and
- 8 parking of vehicles and bicycles shall not be in contravention of
- 9 the Michigan vehicle code, Act No. 300 of the Public Acts of
- 10 1949, as amended, being sections 257.1 to 257.923 of the Michigan
- 11 Compiled Laws.
- 12 (2) Ordinances enacted may apply to streets, roads, high-
- 13 ways, or portions of the township determined by the township
- 14 board or may be limited to specified platted lands within the
- 15 township, and with respect to these lands -shall-be- ARE valid
- 16 and enforceable whether the roads and streets have been dedicated
- 17 to public use or not. Township boards of townships enacting
- 18 ordinances under this section may accept contributions from duly
- 19 constituted representatives of the platted lands benefited by the
- 20 ordinances, to defray administrative and enforcement costs inci-
- 21 dent to the enactment of ordinances.
