February 26, 1991, Introduced by Rep. Bryant and referred to the Committee on State Affairs.

A bill to create the 2020 commission; to prescribe the powers and duties of the commission; and to prescribe the powers and duties of certain state agencies.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. This act shall be known and may be cited as the
- 2 "2020 commission act".
- 3 Sec. 2. As used in this act:
- 4 (a) "Commission" means the 2020 commission created by sec-

- 6 (b) "Department" means the department of commerce.
- 7 Sec. 3. (1) The 2020 commission is created within the

- 9 (2) The commission shall consist of 15 members appointed by
- 10 the governor, with the advice and consent of the senate,

- 1 and various geographic, cultural, educational, and professional
 2 backgrounds.
- 3 (3) Except as otherwise provided in this subsection, the
- 4 members of the commission shall serve for 6-year terms. The ini-
- 5 tial term of office for the members first appointed shall be
- 6 determined by the governor with 5 members serving for 2 years, 5
- 7 members serving for 4 years, and 5 members serving for 6 years.
- 8 (4) A vacancy occurring other than by the expiration of a

- 4 (a) Contract with or otherwise utilize the services of the 5 employees of any state or governmental entity as the commission 6 may require and as may be available to the commission for the 7 purpose of carrying out the commission's duties under this act.
- 8 (b) Employ stenographic and clerical assistants the commis-9 sion considers necessary in order to carry out the commission's 10 duties.
