- 17 INJECTION.
- 18 (i) The following commercially prepared topical
- 19 anesthetic: Proparacaine-HCL-0.5%.

- 23 (D) "THERAPEUTIC PHARMACEUTICAL AGENT" MEANS 1 OR MORE OF

- 25 (i) TOPICALLY ADMINISTERED AGENTS USED FOR THE PURPOSE OF
- 26 TREATING OR ALLEVIATING THE EFFECTS OF DISEASES OR ABNORMAL

- 19 Sec. 17412. (1) Subject to subsection (2), a A licensee
- 20 may administer a -topical ocular diagnostic pharmaceutical agent

- 23 the purposes PURPOSE of determining the refractive, muscular,
- 24 or functional origin of sources of visual discomfort or diffi-

- 10 (a) Has successfully completed 60 classroom hours of study
- 11 in general and clinical pharmacology as it relates to the prac-
- 12 tice of optometry, with particular emphasis on the use of
- 13 -topical ocular diagnostic pharmaceutical agents for examination
- 14 purposes. Not less than 30 of the 60 classroom hours shall be in
- 15 ocular pharmacology and shall emphasize the systemic effects of

- 7 (3) -(4) The course of study and examination required by

- 9 certification, except that the Michigan board of optometry may
- 10 certify applicants who have graduated from a school of optometry
- 11 recognized by the Michigan board of optometry as accredited
- 12 within the 5 years immediately preceding the effective date of
- 13 this section ON OR AFTER APRIL 12, 1979, if the school's curric-

- 17 PHARMACEUTICAL AGENTS FROM A SCHOOL OR COLLEGE OF OPTOMETRY THAT
- 18 IS RECOGNIZED BY THE MICHIGAN BOARD OF OPTOMETRY AS FULLY ACCRED-
- 19 ITED OR HAS SUCCESSFULLY COMPLETED AN EXAMINATION APPROVED BY THE
- 20 MICHIGAN BOARD OF OPTOMETRY ON THE SUBJECT OF TREATMENT AND MAN-
- 21 AGEMENT OF OCULAR DISEASE.
- 22 (C) HAS PAID THE CERTIFICATION FEE TO ADMINISTER THERAPEUTIC
- 23 PHARMACEUTICAL AGENTS PRESCRIBED IN SECTION 61 OF THE STATE
- 24 LICENSE FEE ACT, ACT NO. 152 OF THE PUBLIC ACTS OF 1979, BEING
- 25 SECTION 338.2261 OF THE MICHIGAN COMPILED LAWS.
- 26 SEC. 17437. AN OPTOMETRIST LICENSED AFTER THE EFFECTIVE
- 27 DATE OF THIS SECTION SHALL OBTAIN CERTIFICATION TO ADMINISTER

- 1 DIAGNOSTIC PHARMACEUTICAL AGENTS AND TO ADMINISTER AND PRESCRIBE
- 2 THERAPEUTIC PHARMACEUTICAL AGENTS AT THE TIME OF INITIAL
- 3 LICENSURE.
- 4 Sec. 17708. (1) "Preceptor" means a pharmacist approved by
- 5 the board to direct the training of an intern in an approved
- 6 pharmacy.
- 7 (2) "Prescriber" means a licensed dentist, doctor of medi-
- 8 cine, doctor of osteopathic medicine and surgery, doctor of podi-
- 9 atric medicine and surgery, OPTOMETRIST, veterinarian, or other
