

# HOUSE BILL No. 4459

March 5, 1991, Introduced by Reps. Niederstadt, Bartnik, Pitoniak, Byrum, Baade, McNutt, Dobronski, Anthony, Middaugh and Dalman and referred to the Committee on Towns and Counties.

A bill to amend section 6a of Act No. 1 of the Public Acts of the Extra Session of 1936, entitled as amended "Michigan employment security act," being section 421.6a of the Michigan Compiled Laws.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. Section 6a of Act No. 1 of the Public Acts of  
2 the Extra Session of 1936, being section 421.6a of the Michigan  
3 Compiled Laws, is amended to read as follows:

4 Sec. 6a. ~~The commission may by~~ BY resolution adopted by a  
5 majority of its members, THE COMMISSION MAY destroy or dispose of  
6 ~~any files, records or other papers at any time after they have~~  
7 A DOCUMENT THAT HAS been retained in the commission files FOR NOT  
8 LESS THAN 2 years ~~, and which in its opinion are no longer of~~  
9 ~~any~~ AND THAT IN THE COMMISSION'S OPINION IS OF NO value to the  
10 commission, and may authorize the director to make or cause to be

1 made ~~such summaries or compilations, photographs, duplications~~  
2 ~~or reproductions as he may deem~~ A REPRODUCTION PURSUANT TO THE  
3 RECORDS MEDIA ACT, OR A SUMMARY OR COMPILATION, THAT HE OR SHE  
4 CONSIDERS advisable to preserve the information contained  
5 ~~therein. When originals shall have been destroyed at times and~~  
6 ~~in the manner above specified, the summaries, compilations, pho-~~  
7 ~~tographs, duplications or reproductions referred to above shall~~  
8 ~~be admissible in evidence the same as originals, when~~ IN THE  
9 DOCUMENT. IF AN ORIGINAL DOCUMENT IS DESTROYED OR DISPOSED OF  
10 PURSUANT TO THIS SECTION, A REPRODUCTION OF THE DOCUMENT IN A  
11 MEDIUM PURSUANT TO THE RECORDS MEDIA ACT, A REPRODUCTION CONSIST-  
12 ING OF A PRINTOUT OR OTHER OUTPUT READABLE BY SIGHT FROM SUCH A  
13 MEDIUM, OR A SUMMARY OR COMPILATION OF THE DOCUMENT, IF certified  
14 by the director to be A true ~~—~~ AND accurate ~~and~~ official  
15 ~~copies~~ REPRODUCTION, COMPILATION, OR SUMMARY of the original  
16 ~~—~~ IS ADMISSIBLE IN EVIDENCE THE SAME AS THE ORIGINAL in any  
17 proceeding before the commission, referee, OR appeal board and in  
18 all courts. ~~— if the original would have been admissible~~  
19 ~~therein.~~ Information contained on printouts prepared by auto-  
20 matic data processing equipment ~~shall~~ IS also ~~be~~ admissible  
21 in evidence, if the original ~~files, records or other papers~~  
22 DOCUMENTS from which such information was obtained would have  
23 been admissible. ~~therein.~~

24 Section 2. This amendatory act shall not take effect unless  
25 Senate Bill No. \_\_\_\_\_ or House Bill No. 4438 (request  
26 no. 01788'91) of the 86th Legislature is enacted into law.
