

HOUSE BILL No. 4464

March 5, 1991, Introduced by Reps. Niederstadt, Bartnik, Pitoniak, Byrum, Dobronski, Baade, Anthony, McNutt and Dalman and referred to the Committee on Towns and Counties.

A bill to amend the title and section 1 of Act No. 79 of the Public Acts of 1939, entitled as amended

"An act to authorize the use of certified copies of the records and papers, and certification of no records and papers, in the files of the Michigan state police in judicial and other proceedings; and to declare the effect thereof,"

being section 28.201 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. The title and section 1 of Act No. 79 of the
2 Public Acts of 1939, being section 28.201 of the Michigan
3 Compiled Laws, are amended to read as follows:

12 statement, similarly certified as true by the ~~commissioner of~~
