

HOUSE BILL No. 4476

March 5, 1991, Introduced by Reps. Law, Shugars, Hoffman, O'Connor, Kosteva, Martin, Munsell, Bennett, London, Willis Bullard, Barns, Clack, Wallace and Walberg and referred to the Committee on Corrections.

A bill to amend sections 19 and 20 of chapter 148 of the Revised Statutes of 1846, entitled

"General provisions relating to jails, and the confinement of prisoners therein,"

being sections 801.119 and 801.120 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. Sections 19 and 20 of chapter 148 of the Revised
2 Statutes of 1846, being sections 801.119 and 801.120 of the
3 Michigan Compiled Laws, are amended to read as follows:

4 Sec. 19. ~~Any sheriff or other officer, who shall have~~
5 ~~arrested any prisoner, may pass over, across and through such~~
6 ~~parts of any other county or counties as shall be in the ordinary~~
7 ~~route of travel from the place where such prisoner shall have~~
8 ~~been arrested, to the place where he is to be conveyed and~~

1 ~~delivered, according to the command of the process by which such~~
2 ~~arrest shall have been made.~~ A PEACE OFFICER OF A COUNTY, CITY,
3 VILLAGE, OR TOWNSHIP WHO HAS LAWFUL CUSTODY OF A PRISONER MAY
4 TRANSPORT OR CONVEY THE PRISONER THROUGH ANY PART OF THIS STATE
5 IF NECESSARY TO BRING THE PRISONER BEFORE A COURT OR TO DELIVER
6 THE PRISONER TO A PRISON OR JAIL OR ANOTHER PERSON AS REQUIRED OR
7 PERMITTED BY LAW. WHILE TRANSPORTING A PRISONER PURSUANT TO THIS
8 SECTION, THE PEACE OFFICER HAS THE SAME RIGHTS, POWERS, PRIVI-
9 LEGES, AND IMMUNITIES WITH RESPECT TO THE PRISONER AS POSSESSED
10 BY A SHERIFF.
