THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 8 for the relief of distressed members, visitation of the sick, and
- 9 the payment of a voluntary sick benefit to or for members not

1 exceeding -\$500.00 \$2,000.00 on account of any 1 member, or the 2 buying and selling of products for its members without direct 3 pecuniary profit to the association or its members may operate as 4 a corporation subject to this act. The ladies Lutheran benevo-5 lent federation of Michigan, now incorporated as a nonprofit cor-6 poration, may pay death benefits in an amount not exceeding 7 \$500.00 to any 1 person. The metropolitan club of America, inc., 8 national spirit, and the ladies auxiliary of the metropolitan 9 clubs of America, national spirit, which are incorporated as non-10 profit corporations, may pay death benefits in an amount not to 11 exceed \$1,000.00 to any 1 person. The Venetian club of mutual 12 aid, incorporated as a nonprofit corporation, may pay death and 13 sick benefits in an amount not to exceed \$10,000.00 to any 1 The Warren firemen's benevolent association may pay 15 death and sick benefits in an amount not to exceed \$14,000.00 to 16 any 1 person. The Lansing firemen's benefit association may pay 17 death and sick benefits in an amount not to exceed \$2,000.00 to 18 any 1 person. The Sanilac county police and firemen's fund may 19 pay death and sick benefits in an amount not to exceed \$3,000.00 20 to any 1 person. The Italian-American brotherhood society may 21 pay death and sick benefits in an amount not to exceed \$3,000.00 22 to any 1 person. The Italian-American fraternal club of Dearborn 23 may pay death and sick benefits in an amount not to exceed 24 \$500.00 to any 1 person. The Michigan licensed beverage associa-25 tion may pay death and sick benefits in an amount not to exceed 26 \$5,000.00 to any 1 person who is a licensee of the Michigan

- 21 after due notice and hearing, upon reasonable consideration of
- 22 the ascertained experiences and the character of such kinds of
- 23 business for the purpose of adequately protecting the members and
- 24 securing the solvency of the corporations. The funds of the
- 25 entities securing the reserves shall be invested only in securi-
- 26 ties permitted by the laws of this state for the investment of
- 27 assets of life insurance companies.

- 1 (3) An entity specified in this section which THAT
- 2 obligates itself to the payment of death and sick benefits to its
- 3 members shall not make, issue, or deliver in this state a certif-
- 4 icate or other written evidence of the obligation unless the cer-
- 5 tificate or other written evidence has conspicuously printed on
- 6 the first page in boldface type not smaller than 10 point the
- 7 following statement: This organization does not operate under
- 8 the supervision of the Michigan insurance bureau.
