THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 3 Compiled Laws, is amended by adding section 725 to read as
- 4 follows:
- 5 SEC. 725. (1) AS USED IN THIS SECTION, "STRIP SEARCH" MEANS
- 6 A SEARCH THAT REQUIRES A PERSON TO REMOVE HIS OR HER CLOTHING TO
- 7 EXPOSE UNDERCLOTHING, BREASTS, BUTTOCKS, OR GENITALIA.
- 8 (2) A RECIPIENT OF MENTAL HEALTH SERVICES SHALL NOT BE STRIP
- 9 SEARCHED UNLESS BOTH OF THE FOLLOWING OCCUR:

- (A) THE PERSON AUTHORIZING THE STRIP SEARCH PURSUANT TO
- 2 SUBDIVISION (B) HAS PROBABLE CAUSE TO BELIEVE THAT THE RECIPIENT
- 3 IS CONCEALING A WEAPON, A CONTROLLED SUBSTANCE, OR EVIDENCE OF A
- 4 CRIME.
- 5 (B) THE STRIP SEARCH IS CONDUCTED BY A PERSON WHO HAS
- 6 OBTAINED PRIOR WRITTEN AUTHORIZATION FROM THE PERSON IN CHARGE OF
- 7 THE FACILITY AT WHICH THE RECIPIENT IS RECEIVING MENTAL HEALTH
- 8 SERVICES.
- 9 (3) A STRIP SEARCH THAT IS CONDUCTED UNDER THIS SECTION
- 10 SHALL BE PERFORMED BY A PERSON OF THE SAME SEX AS THE RECIPIENT
- 11 BEING SEARCHED AND SHALL BE PERFORMED IN A PLACE THAT PREVENTS
- 12 THE SEARCH FROM BEING OBSERVED BY A PERSON NOT CONDUCTING OR NEC-
- 13 ESSARY TO ASSIST WITH THE SEARCH. A PERSON WHO ASSISTS IN THE
- 14 STRIP SEARCH SHALL BE OF THE SAME SEX AS THE RECIPIENT BEING

- 16 (4) IF A STRIP SEARCH IS CONDUCTED UNDER THIS SECTION, THE
- 17 PERSON CONDUCTING THE SEARCH SHALL PREPARE A REPORT OF THE STRIP
- 18 SEARCH. THE REPORT SHALL INCLUDE THE FOLLOWING INFORMATION:
- 19 (A) THE NAME AND SEX OF THE RECIPIENT SUBJECTED TO THE STRIP
- 20 SEARCH.
- 21 (B) THE NAME AND SEX OF THE PERSON CONDUCTING THE STRIP
- 22 SEARCH.
- 23 (C) THE NAME AND SEX OF EACH PERSON WHO ASSISTS IN CONDUCT-
- 24 ING THE STRIP SEARCH.
- 25 (D) THE TIME, DATE, AND PLACE OF THE STRIP SEARCH.
- 26 (E) THE JUSTIFICATION FOR CONDUCTING A STRIP SEARCH.

- (F) A LIST OF ALL ITEMS RECOVERED FROM THE RECIPIENT WHO WAS 2 STRIP SEARCHED.
- 3 (G) A COPY OF THE WRITTEN AUTHORIZATION REQUIRED UNDER SUB-4 SECTION (2)(B).
- 5 (5) A COPY OF THE REPORT REQUIRED BY SUBSECTION (4) SHALL BE
- 6 PLACED IN THE PERMANENT RECORD OF THE RECIPIENT. A COPY OF THE
- 7 REPORT SHALL BE GIVEN WITHOUT COST TO THE RECIPIENT AND TO THE
- 8 ORGANIZATION APPOINTED BY THE GOVERNOR TO PROVIDE PROTECTION AND
- 9 ADVOCACY SERVICES PURSUANT TO SECTION 931, SUBJECT TO DELETIONS
- 10 PERMITTED BY SECTION 13 OF THE FREEDOM OF INFORMATION ACT, ACT
- 11 NO. 442 OF THE PUBLIC ACTS OF 1976, BEING SECTION 15.243 OF THE
- 12 MICHIGAN COMPILED LAWS.
- 13 (6) A PERSON WHO CONDUCTS, ASSISTS WITH, OR AUTHORIZES A
- 14 STRIP SEARCH IN VIOLATION OF THIS SECTION IS GUILTY OF A
- 15 MISDEMEANOR.
