- 6 (A) "SENIOR CITIZEN" MEANS A STATE RESIDENT WHO IS 60 YEARS
- 7 OF AGE OR OLDER, AND THE SPOUSE OF THAT STATE RESIDENT REGARDLESS
- 8 OF AGE.

- 1 (B) "UNIT" MEANS THE SENIOR CITIZEN HEALTH INSURANCE ADVISOR
- 2 UNIT CREATED PURSUANT TO SUBSECTION (2).
- 3 (2) THE COMMISSIONER IN CONSULTATION WITH THE DIRECTOR OF
- 4 THE OFFICE OF SERVICES TO THE AGING SHALL ESTABLISH A SENIOR CIT-
- 5 IZEN HEALTH INSURANCE ADVISOR UNIT WITHIN THE INSURANCE BUREAU.
