## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Act No. 300 of the Public Acts of 1949, as
- 2 amended, being sections 257.1 to 257.923 of the Michigan Compiled
- 3 Laws, is amended by adding section 803n to read as follows:
- 4 SEC. 803N. (1) A PERSON WHO WAS A MEMBER OF THE MICHIGAN
- 5 NATIONAL GUARD, THE UNITED STATES ARMED FORCES RESERVE, OR ANY
- 6 BRANCH OF THE ARMED SERVICES OF THE UNITED STATES AND WHO WAS
- 7 CALLED TO ACTIVE DUTY DURING THE PERSIAN GULF WAR MAY APPLY TO
- 8 THE SECRETARY OF STATE FOR A SPECIAL REGISTRATION PLATE, WHICH
- 9 SHALL DISPLAY AN APPROPRIATE VIGNETTE PRECEDING THE REGISTRATION

- 1 NUMBERS AND SHALL HAVE THE WORD "VETERAN" INSCRIBED BENEATH THE
- 2 REGISTRATION NUMBERS.
- 3 (2) APPLICATION FOR A SPECIAL REGISTRATION PLATE SHALL BE ON
- 4 A FORM PRESCRIBED BY THE SECRETARY OF STATE, AND SHALL BE ACCOM-
- 5 PANIED BY ANY PROOF OF THE APPLICANT HAVING BEEN A PERSIAN GULF
- 6 WAR VETERAN WHICH THE SECRETARY OF STATE MAY REQUIRE. THE APPLI-

- 9 (3) UPON PROPER APPLICATION AND PAYMENT OF THE \$5.00 SERVICE
- 10 FEE, THE SECRETARY OF STATE SHALL ISSUE 1 OR MORE SPECIAL REGIS-
- 11 TRATION PLATES FOR EACH APPLICANT FOR USE ON A PASSENGER
- 12 VEHICLE. A PERSON WHO IS HANDICAPPED WHO APPLIES FOR A SPECIAL
- 13 REGISTRATION PLATE UNDER THIS SECTION AND WHO PAYS THE \$5.00
- 14 SERVICE FEE SHALL BE ISSUED A HANDICAPPER TAB AS PROVIDED IN
- 15 SECTION 803F FOR HIS OR HER SPECIAL REGISTRATION PLATE. THE SEC-
- 16 RETARY OF STATE SHALL REQUIRE THE SAME PROOF THAT THE APPLICANT

- 20 ASSESSED THE APPLICABLE TAX PROVIDED IN SECTION 801.
- 21 (4) THE USE OF A SPECIAL REGISTRATION PLATE ON A VEHICLE
- 22 OTHER THAN THE VEHICLE FOR WHICH THE PLATE IS ISSUED, OR BY A
- 23 PERSON WHO DOES NOT QUALIFY UNDER THIS SECTION, IS A
- 24 MISDEMEANOR.
- 25 (5) THE SPECIAL REGISTRATION PLATE ISSUED UNDER THIS SECTION
- 26 SHALL EXPIRE ON THE BIRTHDAY OF THE VEHICLE OWNER. WHEN NEW
- 27 PLATES ARE ISSUED BY THE SECRETARY OF STATE, APPLICATION FOR

- 1 RENEWAL OF THE SPECIAL REGISTRATION PLATE SHALL BE ACCOMPANIED BY
- 2 A \$5.00 SERVICE FEE. THE APPLICANT SHALL NOT BE REQUIRED TO FUR-
- 3 NISH THE PROOF PROVIDED IN SUBSECTION (2).
