THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 5 SEC. 2239. (1) THE DEPARTMENT SHALL IMPLEMENT AND MAINTAIN
- 6 AN INFORMATION SYSTEM WITH INFORMATION ON FREE OR LOW COST HEALTH
- 7 CARE, MENTAL HEALTH, DENTAL HEALTH, AND RESPITE SERVICES THAT ARE
- 8 AVAILABLE TO THE PUBLIC. THE DEPARTMENT SHALL PROVIDE THE
- 9 INFORMATION IN THE SYSTEM TO THE PUBLIC AT NO CHARGE VIA A

- 1 TOLL-FREE TELEPHONE SERVICE. THE DEPARTMENT MAY USE AN EXISTING
- 2 TOLL-FREE TELEPHONE LINE MAINTAINED BY THE DEPARTMENT FOR THE

- 4 (2) A PROVIDER SHALL PROVIDE TO THE DEPARTMENT CURRENT

- 16 (E) THE NAME AND TELEPHONE NUMBER OF A PERSON WHO MAY BE
- 17 CONTACTED FOR ADDITIONAL INFORMATION ON EACH SERVICE.
- 18 (F) SPECIFIC SERVICE AREA COVERED.
- 19 (3) IF ANY OF THE INFORMATION A PROVIDER SUPPLIES TO THE

- 21 NOTIFY THE DEPARTMENT OF THE CHANGE WITHIN 1 MONTH OF THE EFFEC-

- 26 THE INFORMATION IN OTHER WAYS THAT FACILITATE LOCATING AVAILABLE

- 1 (5) NOT LATER THAN 1 YEAR AFTER THE EFFECTIVE DATE OF THIS
- 2 SECTION, THE DEPARTMENT SHALL SEND TO EACH PROVIDER A QUESTION-
- 3 NAIRE THAT THE PROVIDER MAY COMPLETE AND RETURN TO PROVIDE THE
- 4 INFORMATION REQUIRED UNDER SUBSECTION (2). AFTER THE FIRST YEAR
- 5 OF THE INFORMATION SYSTEM, THE DEPARTMENT SHALL SEND A QUESTION-
- 6 NAIRE TO EACH NEW PROVIDER OR, UPON REQUEST, TO A PROVIDER THAT
- 7 HAS A CHANGE IN THE INFORMATION.
- 8 (6) FOR THE FIRST 2 YEARS AFTER THE EFFECTIVE DATE OF THIS
- 9 SECTION, THE DEPARTMENT SHALL MAINTAIN A RECORD OF THE LEVEL AND
- 10 EXTENT OF PARTICIPATION BY PROVIDERS IN THE INFORMATION SYSTEM.
- 11 AT THE CONCLUSION OF THAT PERIOD, THE DEPARTMENT SHALL SUBMIT A
- 12 REPORT TO THE STANDING COMMITTEE OF EACH HOUSE OF THE LEGISLATURE
- 13 THAT HAS JURISDICTION OVER PUBLIC HEALTH POLICY DETAILING AND
- 14 EVALUATING THE LEVEL OF PARTICIPATION BY PROVIDERS AND IDENTIFY-
- 15 ING FURTHER METHODS TO ENCOURAGE FULL PARTICIPATION.
- 16 (7) AS USED IN THIS SECTION, "PROVIDER" MEANS A PERSON,
- 17 OTHER THAN AN INDIVIDUAL, OR GOVERNMENTAL ENTITY THAT PROVIDES
- 18 FREE OR LOW COST HEALTH CARE, MENTAL HEALTH, DENTAL HEALTH, OR
- 19 RESPITE SERVICES THAT ARE AVAILABLE TO THE PUBLIC, WHETHER OR NOT
- 20 THERE ARE SPECIFIC ELIGIBILITY REQUIREMENTS FOR THE SERVICES,
- 21 INCLUDING, BUT NOT LIMITED TO, ALL OF THE FOLLOWING:
- 22 (A) THE DEPARTMENT.
- 23 (B) A LOCAL HEALTH DEPARTMENT.
- 24 (C) THE DEPARTMENT OF MENTAL HEALTH.
- 25 (D) A COUNTY COMMUNITY MENTAL HEALTH PROGRAM.
- 26 (E) THE STATE DEPARTMENT OF SOCIAL SERVICES.

- 1 (F) A COUNTY DEPARTMENT OF SOCIAL SERVICES.
- 2 (G) A HEALTH FACILITY OR AGENCY AS DEFINED IN ARTICLE 17.
- 3 (H) A CHARITABLE ORGANIZATION.
- 4 (I) A PERSON UNDER CONTRACT WITH ANY STATE DEPARTMENT TO
- 5 PROVIDE THOSE SERVICES.
