- 1 FEDERAL SERVICE AND UNTIL THE EXPIRATION OF 180 DAYS AFTER THE

- 14 ESTATE UNDER CHAPTER 60 OR 61 TO SATISFY A JUDGMENT.

- 8 (B) UPON REQUEST OF THE PARTIES IN WRITING OR ON THE RECORD,
- 9 THE COURT IN ITS DISCRETION ENTERS AN ORDER STAYING PROCEEDINGS
- 10 IN THE CIVIL ACTION.
- 11 (5) THIS SECTION APPLIES TO A CIVIL ACTION COMMENCED BEFORE,
- 12 ON, OR AFTER THE EFFECTIVE DATE OF THIS SECTION.
- 13 (6) IF A JUDGMENT PROVIDING ANY TYPE OF RELIEF DESCRIBED IN
- 14 SUBSECTION (1)(A) TO (I) WAS ENTERED BEFORE THE EFFECTIVE DATE OF
- 15 THIS SECTION AGAINST A MEMBER OF A RESERVE COMPONENT OF THE ARMED
- 16 FORCES OF THE UNITED STATES WHILE IN ACTIVE SERVICE OR A MEMBER
- 17 OF THE NATIONAL GUARD OF THE UNITED STATES WHILE IN ACTIVE FED-
- 18 ERAL SERVICE OR DURING THE 180-DAY PERIOD AFTER TERMINATION OF
- 19 THAT SERVICE, UPON REQUEST OF THE MEMBER, THE COURT SHALL ENTER
- 20 AN ORDER STAYING ENFORCEMENT OF THAT JUDGMENT FOR 180 DAYS AFTER
- 21 THE DATE OF THE ENTRY OF THE JUDGMENT.
- 22 (7) AS USED IN THIS SECTION, "PERSON" MEANS THE STATE OR ANY
- 23 INDIVIDUAL, PARTNERSHIP, CORPORATION, ASSOCIATION, LOCAL UNIT OF
- 24 GOVERNMENT, OR OTHER PUBLIC OR PRIVATE ENTITY.
- 25 SEC. 5854A. IF A PERSON CANNOT COMMENCE OR MAINTAIN A CIVIL
- 26 ACTION AGAINST A MEMBER OF A RESERVE COMPONENT OF THE ARMED
- 27 FORCES OF THE UNITED STATES OR A MEMBER OF THE NATIONAL GUARD OF

- 1 THE UNITED STATES UNDER SECTION 1485, THE PERIOD OF LIMITATIONS
- 2 FOR COMMENCING A CIVIL ACTION PRESCRIBED IN THIS CHAPTER IS
- 3 TOLLED FOR THE PERIOD OF TIME PRESCRIBED IN SECTION 1485.
