- 3 AND ETHNIC INTEGRATION WITHIN THE CONSTITUENT DISTRICTS.
- 4 (C) A PROVISION THAT A PUPIL WHO TRANSFERS TO A DIFFERENT
- 5 SCHOOL WITHIN THE INTERMEDIATE DISTRICT UNDER THE PILOT PROGRAM
- 6 SHALL BE INELIGIBLE TO PARTICIPATE IN INTERSCHOLASTIC ATHLETICS
- 7 FOR A PERIOD OF 1 SCHOOL YEAR FROM THE DATE HE OR SHE TRANSFERS.
