THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 5731 of Act No. 368 of the Public Acts
- 2 of 1978, as added by Act No. 49 of the Public Acts of 1987, being
- 3 section 333.5731 of the Michigan Compiled Laws, is amended to
- 4 read as follows:
- 5 Sec. 5731. (1) The agent orange commission is created in
- 6 the department.
- 7 (2) The commission is composed of 14 members, including all
- 8 of the following:

- 1 (a) One member is the director, or his or her designee.
- 2 (b) One member is the attorney general, or his or her 3 designee.
- 4 (c) The GOVERNOR SHALL APPOINT THE remaining members, shall
- 5 be appointed by the governor, with the advice and consent of the
- 6 senate, as follows:
- 7 (i) One member shall be a representative of the Michigan 8 veterans trust fund.
- 9 (ii) Four members shall be researchers who are experts in
- 10 the fields of cytogenetic evaluations, birth defects, immunologi-
- 11 cal studies, neurological studies, toxicology, oncology, or other
- 12 fields relevant to the purposes of this part whose knowledge may
- 13 contribute to the implementation of this part.
- 14 (iii) Five members shall be Vietnam-era veterans, at least 1
- 15 of whom shall be a female Vietnam-era veteran.
- 16 (iv) Two members shall represent the general public, 1 of
