THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Section 405 of Act No. 317 of the Public Acts of

- 5 Sec. 405. (1) In the case of a member of a -full FULLY

- 8 AIRPORT AUTHORITY, or by a state university or college; or of
- 9 a -full FULLY paid fire or police department of a city,

- 1 township, or incorporated village employed and compensated upon a
- 2 full-time basis; a county sheriff and the deputies of the
- 3 county sheriff; members of the state police; conservation
- 4 officers; and OFFICERS OF THE motor carrier inspectors of
- 5 the Michigan public service commission ENFORCEMENT DIVISION OF
- 6 THE DEPARTMENT OF STATE POLICE, "personal injury" shall be con-
- 7 strued to include -respiratory ALL OF THE FOLLOWING, AS
- 8 APPLICABLE:
- 9 (A) RESPIRATORY and heart diseases, or illnesses resulting
- 10 therefrom, which develop or manifest themselves during a period
- 11 while the member of the department is in the active service of

- 16 THEREFROM. AS USED IN THIS SUBDIVISION, "OCCUPATIONAL CANCER"
- 17 MEANS CANCER CAUSED BY EXPOSURE TO SMOKE, FUMES, OR CARCINOGENIC,
- 18 POISONOUS, TOXIC, OR CHEMICAL SUBSTANCES WHILE IN THE PERFORMANCE
- 19 OF DUTIES FOR THE FIRE DEPARTMENT.
- 20 (2) Such respiratory and heart diseases -or AND illnesses
- 21 resulting therefrom, AND OCCUPATIONAL CANCER AND ILLNESSES
- 22 RESULTING THEREFROM are deemed to arise out of and in the course
- 23 of employment in the absence of evidence to the contrary.
- 24 (3) As a condition precedent to filing an application for
- 25 benefits, the claimant, if he or she is one of those enumerated
- 26 in subsection (1), shall first make application for, and do all
- 27 things necessary to qualify for any pension benefits which he or

- 1 she, or his or her decedent, may be entitled to. If a final
- 2 determination is made that pension benefits shall not be awarded,
- 3 then the presumption of "personal injury" as provided in this
- 4 section shall apply. The employer or employee may request 2
- 5 copies of the determination denying pension benefits, 1 copy of
- 6 which may be filed with the bureau.
