- 7 TO SELL THE PRODUCT TO THE DEPARTMENT BECAUSE THE PRODUCT DOES
- 8 NOT MEET THE STANDARD SPECIFICATIONS OR STANDARDS OF PERFORMANCE
- 9 OF THE DEPARTMENT MAY SUBMIT TO THE DEPARTMENT STANDARD
