A bill to amend section 2 of chapter 16 of the Revised Statutes of 1846, entitled as amended

"Of the powers and duties of townships, the election and duties of township officers, and the division of townships,"

as amended by Act No. 77 of the Public Acts of 1989, being section 41.2 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 2 of chapter 16 of the Revised Statutes

- 5 Sec. 2. (1) The inhabitants of an organized township are a

- (a) To sue and be sued and appoint necessary agents and
 attorneys for that purpose.
