"The state school aid act of 1979,"

as amended, being sections 388.1601 to 388.1772 of the Michigan Compiled Laws, by adding section 23a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 5 SEC. 23A. (1) NOTWITHSTANDING ANY OTHER PROVISION OF THIS
- 6 ACT, BASED ON INFORMATION REPORTED TO THE DEPARTMENT BY A PUBLIC
- 7 SCHOOL CORPORATION, THE DEPARTMENT SHALL CALCULATE AND PAY TO A
- 8 PUBLIC SCHOOL CORPORATION FOR EACH PUPIL IN MEMBERSHIP IN A
- 9 SCHOOL OPERATED BY THE PUBLIC SCHOOL CORPORATION AN AMOUNT THAT

- 1 IS EQUAL TO THE AMOUNT OF TOTAL STATE AID THAT WOULD HAVE BEEN
- 2 PAID TO THE PUPIL'S DISTRICT OF RESIDENCE IF THE PUPIL WERE
- 3 ENROLLED IN HIS OR HER DISTRICT OF RESIDENCE. THE PAYMENTS SHALL
- 4 BE MADE IN THE SAME MANNER AND ON THE SAME SCHEDULE AS PAYMENTS

- 3 ADDITION, A PUBLIC SCHOOL CORPORATION AND ITS OFFICIALS ARE
- 4 SUBJECT TO THE SAME PENALTIES AND FORFEITURES AS A DISTRICT UNDER
- 5 ARTICLE 16.
- 6 (4) A PUBLIC SCHOOL CORPORATION SHALL USE THE MONEY IT
- 7 RECEIVES UNDER THIS ACT FOR THE SAME PURPOSES AS A DISTRICT UNDER

- 9 (5) AS USED IN THIS SECTION, "PUBLIC SCHOOL CORPORATION"
- 10 MEANS AN ENTITY OPERATING 1 OR MORE PUBLIC SCHOOLS AS A PUBLIC
