- 1 (2) Within 3 days after the last day on which a candidate
- 2 for a village office may withdraw, the village clerk shall
- 3 deliver to the county clerk of the county in which the village is
- 4 located, a list setting forth the name and address of each candi-
- 5 date for a village office.
- 6 (3) IF THE MEMBERSHIP OF THE VILLAGE COUNCIL IS REDUCED TO
- 7 LESS THAN A QUORUM OF 4, A SPECIAL ELECTION FOR THE PURPOSE OF

- 15 LAST DECENNIAL CENSUS SHALL MAKE TEMPORARY APPOINTMENT OF THE
- 16 NUMBER OF TRUSTEES REQUIRED TO CONSTITUTE A QUORUM FOR THE TRANS-
- 17 ACTION OF BUSINESS BY THE VILLAGE COUNCIL. A TRUSTEE APPOINTED
- 18 UNDER THIS SUBSECTION SHALL HOLD THE OFFICE ONLY UNTIL THE
- 19 TRUSTEE'S SUCCESSOR IS ELECTED AND QUALIFIED. A TRUSTEE WHO IS
- 20 TEMPORARILY APPOINTED UNDER THIS SUBSECTION SHALL NOT VOTE ON THE
- 21 APPOINTMENT OF HIMSELF OR HERSELF TO AN ELECTIVE OR APPOINTIVE
- 22 VILLAGE OFFICE.
