- 4 SEC. 254A. (1) THE SECRETARY OF STATE, IN CONSULTATION WITH

- 6 THEFT PREVENTION PROGRAM UNDER THIS SECTION AND DEVELOP INFORMED
- 7 CONSENT STATEMENT FORMS AND OFFICIAL DECALS FOR USE IN THE
- 8 PROGRAM. PARTICIPATION IN THE PROGRAM BY OWNERS AND
- 9 MUNICIPALITIES IS VOLUNTARY.

- 1 (2) THE PROGRAM SHALL OPERATE AS FOLLOWS:
- 2 (A) AN OWNER MAY SIGN AN INFORMED CONSENT STATEMENT IN THE
- 3 PRESENCE OF A POLICE OFFICER IN A MUNICIPALITY PARTICIPATING IN
- 4 THE PROGRAM. THE STATEMENT SHALL DESCRIBE THE PROGRAM AND INDI-

- 25 STATEMENT FORMS AVAILABLE AT LOCAL SECRETARY OF STATE OFFICES,
- 26 STATE POLICE POSTS, AND THE POLICE DEPARTMENTS OF PARTICIPATING
- 27 MUNICIPALITIES.
