- 5 (2) THE DEPARTMENT SHALL NOT CLOSE A FACILITY UNLESS CLOSURE
- 6 IS APPROVED BY A CONCURRENT RESOLUTION ADOPTED BY RECORD ROLL
- 7 CALL VOTE OF A MAJORITY OF THE MEMBERS ELECTED TO AND SERVING IN
- 8 EACH HOUSE OF THE LEGISLATURE. THE LEGISLATURE SHALL NOT APPROVE
- 9 THE CLOSURE OF A FACILITY DURING A FISCAL YEAR FOR WHICH MONEY IS
- 10 SPECIFICALLY APPROPRIATED FOR THAT FACILITY.
