"Michigan vehicle code,"

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Act No. 300 of the Public Acts of 1949, as
- 2 amended, being sections 257.1 to 257.923 of the Michigan Compiled
- 3 Laws, is amended by adding section 803n to read as follows:
- 4 SEC. 803N. (1) A PERSON WHO WAS A MEMBER OF THE ARMED SERV-
- 5 ICES DURING THE CONFLICT IN GRENADA MAY MAKE APPLICATION TO THE
- 6 SECRETARY OF STATE FOR A SPECIAL REGISTRATION PLATE, WHICH SHALL
- 7 DISPLAY AN APPROPRIATE VIGNETTE PRECEDING THE REGISTRATION
- 8 NUMBERS AND SHALL HAVE THE WORD "VETERAN" INSCRIBED BENEATH THE
- 9 REGISTRATION NUMBERS.

- 1 (2) APPLICATION FOR A SPECIAL REGISTRATION PLATE SHALL BE ON
- 2 A FORM PRESCRIBED BY THE SECRETARY OF STATE, AND SHALL BE ACCOM-
- 3 PANIED BY ANY PROOF OF THE APPLICANT HAVING BEEN A VETERAN OF THE
- 4 CONFLICT IN GRENADA WHICH THE SECRETARY OF STATE MAY REQUIRE.

- 10 VEHICLE. A PERSON WHO IS HANDICAPPED WHO MAKES APPLICATION FOR A
- 11 SPECIAL REGISTRATION PLATE UNDER THIS SECTION AND WHO MAKES PAY-
- 12 MENT OF THE \$5.00 SERVICE FEE SHALL BE ISSUED A HANDICAPPER TAB
- 13 AS PROVIDED IN SECTION 803F FOR HIS OR HER SPECIAL REGISTRATION
- 14 PLATE. THE SECRETARY OF STATE SHALL REQUIRE THE SAME PROOF THAT
- 15 THE APPLICANT IS A HANDICAPPER AS IS REQUIRED FOR ISSUANCE OF A

- 17 PERSON ISSUED 1 OR MORE SPECIAL REGISTRATION PLATES UNDER
- 18 SUBSECTION (1) SHALL BE ASSESSED THE APPLICABLE TAX PROVIDED IN
- 19 SECTION 801.
- 20 (4) THE USE OF A SPECIAL REGISTRATION PLATE ON A VEHICLE
- 21 OTHER THAN THE VEHICLE FOR WHICH THE PLATE IS ISSUED, OR BY A
- 22 PERSON WHO DOES NOT QUALIFY UNDER THIS SECTION, IS A
- 23 MISDEMEANOR.
- 24 (5) THE SPECIAL REGISTRATION PLATE ISSUED UNDER THIS SECTION
- 25 SHALL EXPIRE ON THE BIRTHDAY OF THE VEHICLE OWNER. WHEN NEW
- 26 PLATES ARE ISSUED BY THE SECRETARY OF STATE, APPLICATION FOR
- 27 RENEWAL OF THE SPECIAL REGISTRATION PLATE SHALL BE ACCOMPANIED BY

- 1 A \$5.00 SERVICE FEE. THE APPLICANT SHALL NOT BE REQUIRED TO
- 2 FURNISH THE PROOF PROVIDED IN SUBSECTION (2).
