A bill to amend section 8 of Act No. 48 of the Public Acts of the Second Extra Session of 1963, entitled

"An act to provide for the continuation of Central Michigan university, Eastern Michigan university, Northern Michigan university and Western Michigan university; and to provide for the organization, powers and duties of their boards of control; and to repeal certain acts and parts of acts,"

being section 390.558 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 8 of Act No. 48 of the Public Acts of
- 2 the Second Extra Session of 1963, being section 390.558 of the
- 3 Michigan Compiled Laws, is amended to read as follows:
- 4 Sec. 8. A board of control shall not borrow money on its
- 5 general faith and credit nor OR create any liens upon its

- 1 APPROPRIATIONS COMMITTEES OF THE SENATE AND HOUSE OF
- 2 REPRESENTATIVES, may acquire land or acquire or erect buildings,
- 3 or alter, equip or maintain them, to be used as residence halls,
- 4 apartments, dining facilities, student centers, health centers,
- 5 stadiums, athletic fields, gymnasiums, auditoriums, parking
- 6 structures, and other educational facilities. HOWEVER, THE
- 7 APPROVAL IS REQUIRED ONLY IF THE PROJECT IS ESTIMATED TO COST
- 8 MORE THAN \$500,000.00 OR ANOTHER AMOUNT AS MAY BE STATED IN AN
- 9 APPROPRIATIONS ACT FOR THE FISCAL YEAR IN WHICH THE PROJECT IS
