- 5 (a) "Abortion" means the intentional use of an instrument,

- 9 live birth, or to remove a dead fetus. Abortion does not include

- 3 (b) "Emergency" means -a 1 OR MORE OF THE FOLLOWING:
- 4 (i) A situation in which continuation of the pregnancy of

- 6 life of the minor, as certified in writing by a physician.
- 7 (ii) THE PREGNANT MINOR IS THE VICTIM OF RAPE OR INCEST.
- 8 (iii) A PSYCHOLOGIST OR PSYCHIATRIST CERTIFIES IN WRITING
- 9 THAT THERE IS REASONABLE CAUSE TO BELIEVE THAT THE MINOR WILL
- 10 ATTEMPT OR COMMIT SUICIDE RATHER THAN SEEK THE CONSENT TO AN
- 11 ABORTION FROM A PARENT, LEGAL GUARDIAN, OR THE COURT.

- (d) "Next friend" means a person who is not 1 of the
- 17 following:
- (i) A physician who performs abortions.
- 19 (ii) A person who is employed by, or receives financial con-
- 20 sideration from, a physician who performs abortions or an organi-
- 21 zation that provides abortions or abortion counseling and refer-
- 22 ral services.
- 23 (iii) A person who serves as a board member or volunteer to
- 24 an organization that provides abortions or abortion counseling
- 25 and referral services.
