- 1 Section 1. Section 298b of Act No. 431 of the Public Acts

- 3 being section 18.1298b of the Michigan Compiled Laws, is amended
- 4 to read as follows:
- 5 Sec. 298b. (1) The Michigan capitol park shall consist of
- 6 all real property owned by the state, located in downtown
- 7 Lansing, and bounded by Ottawa street on the north, Allegan
- 8 street on the south, the vacated portion of Sycamore street that
- 9 is located between Ottawa and Allegan streets on the east, and

- 1 Logan street on the west, and designated pursuant to subsection
- 2 (2). Additional real property that is located outside of the
- 3 boundaries named in this subsection may also be designated as
- 4 part of the Michigan capitol park pursuant to subsection (2).

- 6 with the director shall adopt guidelines that designate the real
