## **HOUSE BILL No. 5001**

June 26, 1991, Introduced by Reps. Middaugh and Oxender and referred to the Committee on Towns and Counties.

A bill to amend section 9 of chapter IV of Act No. 283 of the Public Acts of 1909, entitled as amended

"An act to revise, consolidate and add to the laws relating to the establishment, opening, discontinuing, vacating, closing, altering, improvement, maintenance and use of the public highways and private roads, the condemnation of property and gravel therefor; the building, repairing and preservation of bridges; setting and protecting shade trees, drainage, cutting weeds and brush within this state, and providing for the election or appointment and defining the powers, duties and compensation of state, county, township and district highway officials,"

being section 224.9 of the Michigan Compiled Laws.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 9 of chapter IV of Act No. 283 of the
- 2 Public Acts of 1909, being section 224.9 of the Michigan Compiled
- 3 Laws, is amended to read as follows:

1 CHAPTER IV

- 2 Sec. 9. (1) The board of county road commissioners shall 3 constitute and be a body corporate with the right of making,
- 4 and using, AND ALTERING a common seal. and altering the same.
- 5 A majority of the members of the board shall constitute a quorum
- 6 for the transaction of business. The business which the board of
- 7 county road commissioners performs shall be conducted at a public
- 8 meeting of the board held in compliance with THE OPEN MEETINGS
- 9 ACT, Act No. 267 of the Public Acts of 1976, being sections
- 10 15.261 to 15.275 of the Michigan Compiled Laws. Public notice of
- 11 the time, date, and place of the meeting of the board shall be
- 12 given in the manner required by Act No. 267 of the Public Acts
- 13 of 1976.
- 14 (2) The board shall annually appoint 1 member as chairperson
- 15 to serve during the pleasure of the board. The board of county
- 16 road commissioners shall act as an administrative board only and
- 17 the function of the board shall be limited to the formulation of
- 18 policy and the performance of official duties imposed by law and
- 19 delegated by the county board of commissioners, and a member of
- 20 the board of county road commissioners shall not be employed
- 21 individually in any other capacity by, or for other duties with,
- 22 the board of county road commissioners.
- 23 (3) Nothing in this act shall interfere with the work of a
- 24 commissioner during the commissioner's present term of office.
- 25 The board shall appoint a competent superintendent, skilled in
- 26 road building, who may be an engineer and who shall supervise
- 27 road building operations in the county under the direction of the

- 1 board. The board shall be known as the board of county road
- 2 commissioners of the county of \_\_\_\_ and by that name may sue
- 3 and be sued, and may hold in that name the title to land or an
- 4 interest in land, acquired in the manner authorized by law.
- 5 Process may be served on the chairperson or clerk of the board.
- 6 The board may also sell and convey land or an interest in land
- 7 held in the name of the board, or improvements located on the
- 8 land, INCLUDING UNIMPROVED OR UNDEVELOPED PLATTED ROADS AND,
- 9 ALLEYS, when the land, interest in land, or improvements, are not
- 10 a part of a public street, highway, or park, or are not required
- 11 to be used for a public street, highway, or park. A conveyance
- 12 shall be signed by the chairperson and countersigned by the
- 13 clerk, or deputy clerk, of the board. The seal of the board
- 14 shall be attached and the conveyance shall be acknowledged by the
- 15 signers, as authorized by the board, and as the free act and deed
- 16 of the board. The clerk of the county shall be clerk of the
- 17 board of county road commissioners, and shall keep the records
- 18 and accounts of the board. When the record keeping is of suffi-
- 19 cient volume, the board may appoint a secretary, with the consent
- 20 of the county board of commissioners, who shall act as clerk of
- 21 the board, and whose salary, together with the salaries of the
- 22 members of the board of county road commissioners, shall be paid
- 23 by the board of county road commissioners from county road
- 24 funds.
