THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 2 of Act No. 57 of the Public Acts of

- 4 Sec. 2. For the purposes of AS USED IN this act,
- 5 "notarial acts" means acts -which THAT the laws of this state
- 6 authorize notaries public of this state to perform, including the
- 7 administering of oaths and affirmations, taking proof of execu-
- 8 tion and acknowledgments of instruments, and attesting
- 9 documents. Notarial acts may be performed outside this state for
- 10 use in this state with the same effect as if performed by a

- 1 notary public of this state by the following persons authorized
- 2 pursuant to the laws and regulations of other governments in
- 3 addition to any other person authorized by the laws of this

- 5 (a) A notary public authorized to perform notarial acts in

- 7 (b) A judge, clerk, or deputy clerk of any court of record
- 8 in the place in which the notarial act is performed.
- 9 (c) An officer of the foreign service of the United States,
