THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 5 a home for the aged are responsible for all phases of the opera-
- 6 tion of the home and shall assure that the home maintains an

- 8 supervision, assistance, and supervised personal care for its
- 9 residents.

- 8 (D) SHALL NOT ESTABLISH A POLICY OF WITHHOLDING FROM A
- 9 PATIENT, OR AUTHORIZE AN EMPLOYEE TO WITHHOLD FROM A PATIENT, A
- 10 RESUSCITATIVE PROCEDURE REQUIRED BY THAT PATIENT, UNLESS THAT
- 11 PATIENT OR AN AUTHORIZED REPRESENTATIVE OF THAT PATIENT HAS
- 12 REQUESTED IN WRITING THAT NO RESUSCITATIVE PROCEDURES BE IMPLE-
- 13 MENTED ON HIS OR HER BEHALF.
- (2) A PERSON WHO VIOLATES SUBSECTION (1)(D) IS GUILTY OF A
- 15 MISDEMEANOR, PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 1
- 16 YEAR.
- 17 (3) A PERSON WHO VIOLATES SUBSECTION (1)(D) IS SUBJECT TO A
- 18 CIVIL FINE OF NOT MORE THAN \$10,000.00 FOR EACH SEPARATE
- 19 VIOLATION. FOR PURPOSES OF THIS SECTION, EACH DAY OF A VIOLATION
- 20 CONSTITUTES A SEPARATE VIOLATION.
