HOUSE BILL No. 5052

August 1, 1991, Introduced by Rep. Alley and referred to the Committee on House Oversight.

A bill to amend section 3 of Act No. 151 of the Public Acts of 1978, entitled

"An act to provide for the establishment of a base conversion authority; to prescribe the powers and duties of the base conversion authority; to provide for conversion of military installations to civilian uses; and to repeal certain acts and parts of acts,"

being section 3.553 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 3 of Act No. 151 of the Public Acts of
- 2 1978, being section 3.553 of the Michigan Compiled Laws, is
- 3 amended to read as follows:
- 4 Sec. 3. (1) The authority shall consist of -9 11 members.
- 5 who shall be appointed by the governor, with the advice and con-
- 6 sent of the senate. The members shall be as follows:
- 7 (a) One member who is the chairperson of the county board
- 8 of commissioners of the county ELECTED TOWNSHIP SUPERVISOR OF

- 1 THE TOWNSHIP in which the military installation is located, or
- 2 the -chairperson's SUPERVISOR'S designee.
- 3 (b) One member who is -the- A member of the county board of
- 4 commissioners, other than the chairperson, representative of the
- 5 district OF THE COUNTY in which the majority of the land area of
- 6 the military installation is located, or the member's designee.
- 7 (c) One member who is the chairperson of the lead economic
- 8 development agency of the county as designated by resolution of
- 9 the county board of commissioners FROM EACH CHAMBER OF COMMERCE
- 10 IN THE COUNTY in which the military installation is located. -
- 11 or the chairperson's designee.
- (d) One member who is the chief ELECTED officer of the
- 13 municipality in which the majority of the land area of the mili-
- 14 tary installation is located, or the officer's designee.
- (e) One member who is a representative of the legislative
- 16 body of the municipality with the largest population in the
- 17 county MEMBER OF THE BOARD OF THE INTERMEDIATE SCHOOL DISTRICT
- 18 in which the military installation is located.
- 19 (f) The director of commerce or the director's designee.
- 20 (g) The director of the department of management and budget
- 21 or the director's designee.
- 22 (h) The director of labor, or the director's designee.
- 23 (G) -(i) The director of the department of natural
- 24 resources, or the director's designee.
- 25 (H) A MEMBER OF THE COMMUNITY SERVICE AGENCY SERVING THE
- 26 AREA IN WHICH THE MILITARY INSTALLATION IS LOCATED.

- 1 (I) A MEMBER OF A LOCAL CITIZENS GROUP CONCERNED WITH
- 2 ENVIRONMENTAL ISSUES.
- 3 (J) A PERSON WHO HAS RETIRED FROM MILITARY SERVICE AND WHO
- 4 WAS LIVING ON THE MILITARY INSTALLATION AT THE TIME THE INSTALLA-
- 5 TION WAS DESIGNATED FOR CLOSURE.
- 6 (2) The authority shall exist for 3 years, with 2 additional
- 7 1-year extensions if each extension is provided by concurrent
- 8 resolution of the state legislature.
- 9 (3) Each member of the authority shall serve while the
- 10 member holds the respective office specified in subsection (1).
- 11 A vacancy shall be filled in the same manner as the original
- 12 appointment.
- 13 (4) The authority shall hold an annual meeting each
- 14 January. Additional meetings may be conducted as are necessary.
- 15 At least 1 meeting a year shall be held on the military
- 16 installation. At a meeting of the authority a majority vote of
- 17 all members appointed and serving is necessary for a decision. A
- 18 quorum consists of $\frac{-5}{}$ 6 members.
- 19 (5) The per diem compensation of the authority and the
- 20 schedule for reimbursement of expenses shall be established by
- 21 the legislature.
- 22 (6) The authority shall elect annually from its membership a
- 23 chairperson, a vice-chairperson, a secretary, and a treasurer.
- 24 The authority may employ experts, consultants, administrative
- 25 staff, and other personnel the authority considers necessary in
- 26 the performance of its responsibilities under this act.
