- 7 MICHIGAN COMPILED LAWS, AND EMPLOYEES OF PERSONS LICENSED UNDER

- 9 PUBLIC ACTS OF 1929 WHILE PERFORMING MAINTENANCE, SERVICE,
- 10 REPAIR, REPLACEMENT, ALTERATION, MODIFICATION, RECONSTRUCTION, OR
- 11 UPGRADING OF CONTROL WIRING CIRCUITS AND ELECTRICAL COMPONENT
- 12 PARTS WITHIN EXISTING MECHANICAL SYSTEMS DEFINED IN THE MECHANI-
- 13 CAL AND PLUMBING CODES PROVIDED FOR IN THE STATE CONSTRUCTION
- 14 CODE ACT OF 1972, INCLUDING, BUT NOT LIMITED TO, ENERGY MANAGE-
- 15 MENT SYSTEMS, RELAYS AND CONTROLS ON BOILERS, WATER HEATERS, FUR-
- 16 NACES, AIR CONDITIONING COMPRESSORS AND CONDENSERS, FAN CONTROLS,
- 17 THERMOSTATS AND SENSORS, AND ALL INTERCONNECTING WIRING ASSOCI-
