- 4 SEC. 377C. (1) AS USED IN THIS SECTION:
- 5 (A) "DEFACE" MEANS TO MAR, DESTROY, ERASE, OBLITERATE, OR
- 6 OTHERWISE DAMAGE REAL OR PERSONAL PROPERTY, WITH PAINT OR ANY
- 7 OTHER SUBSTANCE OR BY USE OF PHYSICAL OR MECHANICAL FORCE.

- 1 (B) "LICENSE" MEANS THAT TERM AS DEFINED IN SECTION 25 OF 2 THE MICHIGAN VEHICLE CODE, ACT NO. 300 OF THE PUBLIC ACTS OF
- 3 1949, BEING SECTION 257.25 OF THE MICHIGAN COMPILED LAWS.
- 4 (2) A PERSON IS GUILTY OF VANDALISM IN THE FIRST DEGREE IF
- 5 THE PERSON MALICIOUSLY DEFACES THE REAL OR PERSONAL PROPERTY OF
- 6 ANOTHER PERSON, AND THE DAMAGE CAUSED BY THE DEFACEMENT OR COST

- 27 ANOTHER PERSON, AND THE DAMAGE CAUSED BY THE DEFACEMENT OR THE

- 2 VANDALISM IN THE FOURTH DEGREE IS A MISDEMEANOR PUNISHABLE BY
- 3 IMPRISONMENT FOR NOT MORE THAN 6 MONTHS, OR A FINE OF NOT MORE
- 4 THAN \$1,000.00, OR BOTH.
- 5 (6) AS PART OF THE SENTENCE FOR A PERSON FOR A VIOLATION OF
- 6 SUBSECTION (2), (3), (4), OR (5), THE COURT MAY DO 1 OR BOTH OF
- 7 THE FOLLOWING:
- 8 (A) ORDER THE SECRETARY OF STATE TO SUSPEND THE LICENSE OF
- 9 THE PERSON OR DENY THE ISSUANCE OF A LICENSE TO THE PERSON FOR A
- 10 PERIOD OF NOT MORE THAN 1 YEAR. THE PERSON WHOSE LICENSE IS
- 11 ORDERED SUSPENDED UNDER THIS SECTION SHALL IMMEDIATELY SURRENDER
- 12 THE LICENSE TO THE COURT. THE COURT SHALL IMMEDIATELY FORWARD
- 13 THE LICENSE AND ABSTRACT OF CONVICTION TO THE SECRETARY OF
- 14 STATE. THE ABSTRACT OF CONVICTION SHALL INDICATE THE PERIOD OF
- 15 THE SUSPENSION ORDERED BY THE COURT UNDER THIS SECTION.
- 16 (B) ORDER THE PERSON TO REPAIR THE DEFACED PROPERTY HIMSELF
- 17 OR HERSELF, OR PAY THE COST OF REPAIRING THE DEFACED PROPERTY.
