- 6 CIVIL BENCH WARRANT ISSUED BY THE CIRCUIT COURT THAT ARISES OUT
- 7 OF A DOMESTIC RELATIONS MATTER.

- 10 (iii) ANY INJUNCTIVE OR RESTRAINING ORDER ISSUED BY THE CIR-
- 11 CUIT COURT THAT RESTRAINS OR ENJOINS A SPOUSE, A FORMER SPOUSE,
- 12 OR A PERSON RESIDING OR HAVING RESIDED IN THE SAME HOUSEHOLD AS
- 13 THE VICTIM FROM ENTERING ONTO PREMISES, FROM ASSAULTING, BEATING,
- 14 MOLESTING, OR WOUNDING A NAMED PERSON, OR FROM REMOVING MINOR
- 15 CHILDREN FROM THE PERSON HAVING LEGAL CUSTODY OF THE CHILDREN.
