- 4 SEC. 22B. (1) A POLICE OFFICER OF A VILLAGE HAS THE SAME
- 5 AUTHORITY AS A DEPUTY SHERIFF TO EXECUTE A CIVIL BENCH WARRANT
- 6 ISSUED BY THE CIRCUIT COURT THAT ARISES OUT OF A DOMESTIC
- 7 RELATIONS MATTER.
