## **HOUSE BILL No. 5208**

October 1, 1991, Introduced by Reps. Kosteva, Gubow, DeMars, Dobronski, Gire, Olshove, Weeks, Profit and Wozniak and referred to the Committee on Judiciary.

A bill to amend chapter XII of Act No. 215 of the Public Acts of 1895, entitled as amended

"An act to provide for the incorporation of cities of the fourth class; to provide for the vacation of the incorporation thereof; to define the powers and duties of such cities and the powers and duties of the municipal finance commission or its successor agency and of the department of treasury with regard thereto; to provide for the levy and collection of taxes, borrowing of money, and issuance of bonds and other evidences of indebtedness by cities; to define the application of this act and provide for its amendment by cities subject thereto, and to validate such prior amendments and certain prior actions taken and bonds issued by such cities,"

being sections 92.1 to 92.6 of the Michigan Compiled Laws, by adding section 4a.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 12 (B) A LAW OF THIS STATE REGARDING ANY OF THE FOLLOWING:
- 13 (i) CHILD CUSTODY OR VISITATION.
- 14 (ii) CHILD SUPPORT, OR SPOUSE OR FORMER SPOUSE SUPPORT.
- 15 (iii) ANY INJUNCTIVE OR RESTRAINING ORDER ISSUED BY THE CIR-
- 16 CUIT COURT THAT RESTRAINS OR ENJOINS A SPOUSE, A FORMER SPOUSE,
- 17 OR A PERSON RESIDING OR HAVING RESIDED IN THE SAME HOUSEHOLD AS
- 18 THE VICTIM FROM ENTERING ONTO PREMISES, FROM ASSAULTING, BEATING,
- 19 MOLESTING, OR WOUNDING A NAMED PERSON, OR FROM REMOVING MINOR
- 20 CHILDREN FROM THE PERSON HAVING LEGAL CUSTODY OF THE CHILDREN.
